How does Mike's Rent To Own protect my personal information?	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We also maintain physical, electronic and procedural safeguards. Only authorized employees have access.</p> <p>All the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.</p>

Why can't I limit all sharing?	<p>You have the right to limit only:</p> <p>Sharing for affiliates' everyday business purposes - information about your creditworthiness Affiliates from using your information to market to you Sharing for non-affiliates to market to you</p>

<p>What happens when I limit sharing for an account I hold jointly with someone else?</p>	<p>Your choices will apply to everyone on that account.</p>

<p>Affiliates</p>	<p>Companies related by common ownership or control. They can be financial or non-financial companies.</p>
<p>Non-Affiliates</p>	<p>Financial and non-financial companies not related by common ownership or control. They can be financial and non-financial companies.</p> <p><i>Non-affiliates we share with can include companies to market only our products and services to you, to process your transactions, maintain your account(s), respond to court orders and legal investigations, or report to credit bureaus.</i></p>

Joint Marketing	<p>A formal agreement between companies that together market products or services to you.</p> <p><i>Our joint marketing partners may include financial product companies or service companies.</i></p>
Text Messaging	<p>By providing your cell phone number and opting in, you have provided us with consent to send you account-related text messages, like payment reminders and notification, as well as promotional messages, like special offers and discounts, in conjunction with the services you have requested. Your cellular provider's Msg. & Data Rates may apply to our confirmation message and all subsequent messages. You understand the text messages we send may be seen by anyone with access to your phone. Accordingly, you should take steps to safeguard your phone and your text messages if you want them to remain private.
